3.1. Level of qualification:

Bachelor' degree. Bachelor' degree is awarded to a person who has the general secondary education or vocational secondary education. Bachelor' degree is a necessary condition for admission to receiving of the Master's degree.

3.2. Official length of programme:

Four years or 208 weeks: 130 weeks of the theoretical courses (lectures, seminars, laboratory works), 15 weeks of practice, 25 weeks for examinations, 38 weeks of vacations. The total credit hours of the educational professional workload is 240 credit hours of ECTS.

4.2. Programme requirements:

Bachelor of International Relations should:

- know the main principles in the sphere of political, humanitarian, social and economic and legal science; analyze social problems and processes; know how to use the methods of such science in different kinds of professional and social activity;
- know the main stages of the history of Kyrgyzstan and its foreign policy as well as the history of the other developed countries and civilizations of the world; to understand the meaning and mechanisms of historical succession;
- know the main problems of modern international relations, mechanisms and conformity with law of their forming and development, main theories and conceptions related to the development and functioning of international relations; have the ability to use their conclusions, methods and ways of research for analyzing the problems rising during their professional activity;
- know the main problems of foreign policy and national security of the Kyrgyz Republic;
- know foreign languages, fulfill the functions of translator, referent translator, continue the education and fulfill the professional activity in non-native environment;
- know the Constitution of the Kyrgyz Republic, ethic and legal norms, regulated the mutual relations in the society and between the society and , taking into account them in the professional activity;
- be ready to work in the team and know the principles of pedagogical activity.

4.4. Grading scheme and grade distribution guidance:

Grading is based on the State four-mark grading scale:

- The «EXCELLENT» mark is given for remarkable result with some unimportant incompletes.
- The «GOOD» mark is given to a student, who has good results in spite of some incompletes.
- The «SATISFACTORY» mark means conscientious result but with some serious incompletes in the theoretical grounding of a student.
- The «UNSATISFACTORY» mark is the result which corresponds to minimally possible criteria but with the right of passing the discipline again. The additional work for receiving a credit is necessary.
- The «PASSED» mark is given to a student, if he/she has attended a course in a full volume in accordance with the State Educational Standard and has an ability to apply the received knowledge in practice.

8. INFORMATION ON THE NATIONAL HIGHER EDUCATION SYSTEM

8.1. Description of the National system of higher education of the Kyrgyz Republic:

The Kyrgyz Higher Education system consists of the following High Institutions:

1. The Universities, which:
 - implement programs of higher education, undergraduate and postgraduate, in different fields;

- carry out fundamental and applied research on a wide range of issues;
 - prepare, train, retrain and ensure professional development, and also prepare scientists and scientific-researchers (candidates and doctors of sciences);
 - constitute a scientific and methodological center in different fields.
2. The Academies, which:
 - implement programs of higher education, undergraduate and postgraduate in its field of scientific activity;
 - carry out fundamental and applied research on a wide range of issues;
 - prepare, train, retrain and ensure professional development, and also prepare scientists and scientific-researchers (candidates and doctors of sciences);
 3. The Institutes are the structural subdivisions of the University or Academy, which:
 - implement programs of higher education and educational programs for undergraduates;
 - prepare, train, retrain, and ensure professional development of workers with higher education;
 - prepare scientific and scientific-research pedagogical personnel for certain sphere of professional activity;
 - carry out some fundamental and applied researches of fundamental and applied character, according to the specialists' prepared profile.
 4. The Specialized Institutes (conservatories, specific purpose institutes), which:
 - implement programs of higher and postgraduate education;
 - prepare, train, retrain, ensure professional development, and also prepare scientific and scientific-research pedagogical personnel for certain sphere of professional activity;
 - carry out applied scientific researches.

8.2. Educational and professional programs and awarded qualifications:

Higher education institutes of the Kyrgyz Republic conduct education according to the following educational professional programs:

- Bachelor's degree. Apprenticeship: 4-5 years. To get a Bachelor's degree one needs to pass the final state examination and defend a Bachelor's thesis.
- Master's degree. Apprenticeship: 2-3 years. To get a Master's degree one needs to pass the final state examination and defend a Master's thesis.
- Specialist's qualification. Apprenticeship: 5-6 years. To get a Specialist's qualification one needs to pass the final state examination and defend a thesis paper.
- Postgraduate degree. Master and Specialist has the right to enter postgraduate courses. Apprenticeship: 3-4 years. The education ends with the defending of Scientific thesis conferring to Ph.D. or Candidate's degree.
- Doctor's degree. Apprenticeship: 3 years. Ph.D. holders with practical work experience have the right to enter Doctor's degree courses. The education for Doctor's degree ends with the defending of a Doctoral thesis conferring to Doctor's degree.

8.3. License and attestation of the educational professional programs:

Institutes of higher education should have a license of Ministry of Education and Science of the Kyrgyz Republic to implement the educational activity in order to realize educational professional programs of different levels.
